OWNER REQUESTED CHANGE OF CONTRACTOR:

When an owner requests a Change of Contractor, this form shall stand as the formal submittal by the owner to the City of Thomasville and the Building Official stating the reason for the change and stating that the above mentioned is held harmless from any legal involvement regarding this request. The existing permit may be cancelled/closed or may be abdicated to another contractor. In addition, this form shall serve as proof to the Building Official that the contractor on record for the subject permit has been notified of the intent to change the contractor. See the attached form "Change of Contractor Affidavit" to be used in lieu of the letter notifications.

When an owner requests a Change of Sub-Contractor, the procedures as above apply, with the exception that both the owner of record and the contractor shall sign this form as hold-harmless letter to the Building Official.

Any portion of work completed under the existing permit shall be suspended until such time that a new contractor or sub-contractor is installed in the stead of the permit holder or; a new application for permit is made and new permit(s) secured.

CONTRACTOR REQUEST TO WITHDRAW FROM A PERMITTED JOB:

When a contractor or sub-contractor wishes to withdraw from an issued permit for a job without cancelling the permit, the contractor or sub-contractor shall submit proof via this form to the Building Official that the owner of record has been notified, and with such submittal that he/she holds harmless the City of Thomasville and the Building Official from any legal involvement as a result of this action of the Contractor or sub-contractor. See the attached form "**Change of Contractor Affidavit**" to be used in lieu of the letter notifications.

TO BE NOTED WITH THIS ACTION

Any permit may be transferred or reassigned to a new State licensed Contractor or subcontractor of the respective trade with this form. In taking such action, the new entity assumes all responsibility for all work performed from the permit inception. Cancelation of the permit and new application for completion of the proposed work provided that the new contractor or sub-contractor are only responsible for work from that date forward.
