The Council of the City of Thomasville met in regular session with Mayor Greg Hobbs presiding and the following Councilmembers present: Mayor Pro Tem Terry Scott, Councilmembers Flowers, Hufstetler, and Mobley. Also present were the Interim Utilities Superintendent, Keith Bass; Asst. Utilities Superintendent, Chris White; City Attorney, Tim Sanders; other staff, members of the press and citizens. The meeting was held at the Thomasville Municipal Auditorium at 144 East Jackson Street in Thomasville, Georgia.

Mayor Hobbs called the meeting to order at 5:00 PM. Councilmember Flowers gave the invocation. Mayor Pro Tem Scott led those present in the Pledge of Allegiance.

On motion of Mayor Pro tem Scott, and seconded by Councilmember Flowers, the minutes of the City Council meeting held on June 11, 2018 were unanimously approved as presented.

Mayor Hobbs opened the meeting to citizens to be heard on non-agenda items. Attorney Joe Dent, Watson Spence, LLP of Albany, Georgia, addressed Council. Mr. Dent reported Watson Spence, LLP had been retained by several concerned citizens who will be adversely impacted by the Thomasville City Council's vote in regards to Pinetree Boulevard. Mr. Dent reported the City Council's May 14, 2018 vote to accept a three-lane design plan for road improvements on Pinetree Boulevard had not been properly noticed to the public and indications that would constitute an emergency vote to accept the design plan did not exist. He further reported information received from recent open records requests indicate certain Councilmembers circumvented City staff and were working directly with Falcon Engineering in reference to Pinetree Boulevard. Mr. Dent also reported the only traffic study for Pinetree Boulevard revealed the current road would meet traffic needs until 2026. Mr. Dent concluded by stating on behalf of his clients he respectfully requested the Thomasville City Council to rescind their vote of May 14, 2018 regarding Pinetree Boulevard. He further stated that if the City Council chose not to rescind the vote, his clients were prepared to move forward with litigation and would request the Attorney General to be involved as he deemed appropriate.

Sophia Latz, Preservation Programs Manager, Thomasville Landmarks addressed Council with concerns regarding the three Walcott Street structures set for demolition. Ms. Latz noted the Walcott Street structures are considered historically significant to Thomasville, are contributing structures in the National Registry and their removal would cause undue strife in the adjacent neighborhoods. She requested of Council to consider rehabilitation for such structures prior to demolition ordinances. Ms. Latz reported such structures could be potentially rehabilitated and considered as an option for affordable housing. Ms. Latz reported Landmarks would be interested in working with the City to potentially resuscitate these structures.

Keith Thomas addressed Council and voiced his concerns regarding the current salaries of long time City of Thomasville employees. He displayed a poster board with listed salaries and noted these salaries were excessive and there was not enough diversity in these positions. Mr. Thomas noted longtime employees should retire to allow a younger generation to assume these positions with lower salaries. He concluded his concerns by noting he would continue to address Council regarding this matter until there were changes.

Stephan Thompson, 218 Short Street, Thomasville, Georgia, addressed Council as a member of the Weston Park Redevelopment Committee. Mr. Thompson noted although there has been activity and improvements made at Weston Park, he requested Council to officially adopt the redevelopment plan for Weston Park. Mr. Thompson reported having discussions with Douglas Alumni regarding grievances and responsibilities; as well as the Thomasville YMCA regarding programming of the Park. Mr. Thompson

concluded by noting Dewey City was one of the most historic areas and requested the City work together and officially adopt the plan to redevelop Weston Park for the community.

There being no further citizens to be heard, Council moved on to the printed agenda.

Under Old Business, Council considered on second reading an ordinance to amend Chapter 14, Section 99 of the Thomasville Municipal Code. Mayor Hobbs recognized Asst. Utilities Superintendent White who reported the ordinance remained unchanged from the first reading. On motion of Councilmember Flowers, and seconded by Mayor Pro Tem Scott, the following ordinance was unanimously ordered read for the second time, passed and adopted:

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF THOMASVILLE BY AMENDING CHAPTER 14, CAPTIONED "SEWERAGE\*", SO AS TO STRIKE IN ITS ENTIRETY SECTION 14-99, CAPTIONED "EFFLUENT LIMITATIONS," OF ARTICLE V, CAPTIONED "USE OF THE PUBLIC SEWERS RESTRICTED," AND TO ADD AN ENTIRELY NEW SECTION 14-99, CAPTIONED "EFFLUENT LIMITATIONS," OF ARTICLE V, CAPTIONED USE OF THE PUBLIC SEWERS RESTRICTED," OF CHAPTER 14, CAPTIONED "SEWERAGE\*," TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE AN EFFECTIVE DATE OF THIS ORDINANCE; AND FOR OTHER PURPOSES.

#### **SECTION I**

BE IT ORDAINED by the Council of the City of Thomasville, and it is hereby ordained by the authority of the same, that the Code of the City of Thomasville is hereby amended by striking in its entirety Section 14-99, captioned "Effluent limitations," of Article V, captioned "Use of the Public Sewers Restricted," of Chapter 14, captioned "Sewerage\*".

#### SECTION II

BE IT FURTHER ORDAINED by the Council of the City of Thomasville, and it is hereby ordained by the authority of the same that the Code of the City of Thomasville is hereby amended by adding an entirely new Section 14-99, captioned "Effluent limitations," of Article V, Captioned "Use of the Public Sewers Restricted," of Chapter 14, captioned "Sewerage\*," so as to read as follows:

Section 14-99 Effluent limitations.

(a) No user shall discharge wastewater which exceeds the following concentration limits at the point of discharge into the city's collection system:

(b) The above concentration limits are set by the city council as maximal. The limits may be reduced by order of the utilities superintendent at any time when it is found that the wastewater plant does not meet its proper limits of treatment, and the utilities superintendent may establish concentration limits for other substances as may be appropriate. All users on the system must comply with such revised standard limits.

#### SECTION III

BE IT FURTHER ORDAINED that this ordinance shall become effective on June 20, 2018.

#### **SECTION IV**

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed for the purposes of this ordinance only.

# **SECTION V**

BE IT FURTHER ORDAINED that upon its final adoption the provisions of this ordinance shall be made a part of the official codified ordinances of the City of Thomasville.

#### **SECTION VI**

This ordinance was read for the first time in a lawful meeting of the Council of the City of Thomasville held on June 11, 2018, and read the second time, passed and adopted in like meeting held on June 20, 2018.

Council considered on second reading three separate ordinances to demolish three structures located on Walcott Street. Mayor Hobbs recognized Chief Building Official Mark Harmon, who reported each ordinance remained unchanged from the first reading. Harmon noted these structures have met the thresholds for demolition and the Building Department was made aware of Thomasville Landmarks' request of potential rehabilitation of the structures on the preceding day. Harmon reported the anticipated time frame prior to demolition will allow Landmarks time to meet with owners regarding potential rehabilitation options. Discussion ensued regarding rescinding the vote if any structure was found to be appropriate for rehabilitation. City Attorney Sanders noted if any structures are deemed salvageable following Landmarks' due diligence, the vote to demolish the structure(s) would require amendment.

Mayor Hobbs recognized City Attorney Sanders, who summarized MEAG Sr. Vice President & General Counsel Pete Degnan's Council Workshop discussion as the Petition to Increase Bonding Capacities would allow MEAG to continue to issue bonds and increase financing opportunities for refinancing interest loans and decrease debt service cost for each of MEAG's 49 member cities. He further summarized the MEAG Petition's narrow timeline and signed agreements with all 49 member cities.

On motion of Councilmember Hufstetler, and seconded by Councilmember Mobley, Council unanimously approved the following resolution:

### RESOLUTION

WHEREAS, the City of Thomasville is a Participant in Power Sales Contracts in respect of MEAG Projects One, Two, Three and Four; and

WHEREAS, MEAG anticipates filing a petition to institute a bond validation proceeding in the Superior Court of Fulton County, Georgia, on or about June 27th, 2018, to increase the bonding Authority of Projects One, Two, Three and Four under a more flexible formula in order to allow MEAG to take advantage of future refinancing opportunities for the purposes of lowering the overall debt service of MEAG; and

WHEREAS, the City of Thomasville desires to approve the Answer to the Petition and Complaint, both in the substantial form as attached hereto as Exhibit A and Exhibit B, respectively, and to authorize the Mayor to execute the Verification and the Acknowledgment of Service of the Petition and Complaint on behalf of the City of Thomasville; and

NOW, THEREFORE, BE IT RESOLVED, AND IT IS HEREBY RESOLVED, that the Answer to the Petition and Complaint, in the substantial form as attached hereto as Exhibit A is hereby approved and the Mayor is authorized to execute the Verification and the Acknowledgment of Service of the Petition and Complaint on behalf of the City of Thomasville;

So resolved this the 20th day of June, 2018.

Council considered a resolution to change the current status of the South Pinetree Boulevard Project. Councilmember Flowers reported of the controversy revolving around the City Council's May 14, 2018 vote to accept plans for road improvements for South Pinetree Boulevard as designed by Falcon Engineering, Norcross, Georgia, for Thomas County and submitted to Georgia Department of Transportation by Thomas County Board of Commissioners. Councilmember Flowers moved to change the status of the South Pinetree Boulevard Project from the current 3-lane proposal to a neutral status to allow for further discussion during the next Council meeting. Councilmember Mobley requested to change the status instead to suspension of all work on the project.

Following brief discussion, Councilmember Flowers amended his motion and moved to suspend all activity regarding the South Pinetree Boulevard Road Improvement Project so as to allow for further discussion, as well as community input, at the July 23, 2018 City Council meeting. Councilmember Mobley seconded the motion. Further discussion ensued regarding clarification of the motion and it was noted the motion was not to rescind the May 14, 2018 vote by Council, it was to stop any work/activity on the project except discussions. Councilmembers Mobley noted he would like to view all plans for the Boulevard. Mayor Hobbs called for a vote on the amended motion, the motion was approved with the following votes were recorded:

AYES: Mayor Pro Tem Scott, Councilmembers Flowers and Mobley Mayor Hobbs and Councilmember Hufstetler did not vote.

Council considered award for professional audit services for the City of Thomasville. Purchasing Administrator, Anthony Choice, reported the current contract is with Lanigan & Associates and will expire in December. He further reported as per recommendation of City Council concerning audit services, a

Request for Proposal (RFP) was sent to five (5) qualified firms as well as placed on the City of Thomasville's website for the purpose of seeking a qualified firm to provide auditing services for the City of Thomasville Financials for 2018, 2019 & 2020. An RFP was compiled and sent to these firms as well as an evaluation committee was chosen to evaluate the proposals on technical qualifications as a primary focus with price the secondary focus. It was noted the evaluation committee included Audit Committee Member Councilmember Flowers. Choice reported five (5) firms received proposal requests, only two (2) firms submitted proposals: Lanigan & Associates of Thomasville, Georgia and Mauldin & Jenkins of Macon, Georgia. Choice noted the scoring processes of the evaluation committee and following three separate processes, staff recommended Mauldin & Jenkins of Macon, Georgia. Choice noted a transition plan has been devised with specific timelines and transactions to assist Mauldin & Jenkins and ensure a seamless transition. He noted if Council approved the Mauldin & Jenkins proposal, the transition process could begin as early as July or August 2018. Choice also noted common practice within municipalities is to retain the same auditing firm for a time of 3-5 years. Councilmember Mobley noted this was also recommended during a recent conference hosted by the Georgia Municipal Association. Following are the proposals considered:

On motion of Councilmember Mobley, and seconded by Councilmember Hufstetler, Council unanimously approved the award for professional audit services for the City of Thomasville, fiscal years 2018, 2019 and 2020, to Mauldin & Jenkins, of Macon, Georgia

Council considered the award of purchase of equipment for the Technical Services Department. Asst. Utilities Superintendent, Chris White noted \$35,000.00 was included for a replacement vehicle in the 2018 capital budget for Technical Services to replace unit # 10606. This vehicle is used in daily operations for electric metering, traffic control maintenance, SCADA maintenance and other duties of the department. This vehicle typically stays loaded with various equipment/supplies and often tows various trailers in the fleet, thus requiring the payload of a ¾ ton unit. The following bids were reviewed:

White reported after staff's evaluation of the bids, it was recommended the purchase of (1) Ford Transit Van equipped with a 3.5L Eco Boost engine from Tallahassee Ford. This recommendation is based on the engine HP and torque capacity over the 3.7L unit. On motion of Mayor Pro Tem Scott, and seconded by Councilmember Flowers, Council unanimously approved the award of purchase of one <sup>3</sup>/<sub>4</sub> ton Cargo Van

for the Technical Services Department to Tallahassee Ford of Tallahassee, Florida in the amount of \$26, 998.00, with third-party financing if necessary.

Council considered bids and award for the purchase of construction contract for the Thomasville Community Trail Phase 1A. City Engineer, Wayne Newsome reported bids were received which included furnishing of all labor, material, and equipment and performing all work required to construct the following: removal of existing sidewalk and placement of new trail along Victoria Place and West Jackson Street. The work also includes storm drain construction, curb and gutter, and new Trail along Remington Avenue and along Properties belonging to Trinity Church and Landmark, LLC from Remington Avenue to Stevens Street. Additionally, pavement milling and resurfacing will be completed on a portion of Remington Avenue between S. Stevens Street and W. Jackson Street. Also included is some pavement striping for parking along Remington Avenue. Work is to be completed within 90 consecutive calendar days of Notice to Proceed. The following is a summary of bids received:

On motion of Councilmember Hufstetler, and seconded by Councilmember Flowers, Council unanimously approved the award of contract for the 2017 Thomasville Community Trail Phase 1A Project to David Taylor Construction, Inc. of Moultrie, Georgia in the amount of \$288,212.68 as being the lowest bid received, utilizing available 2012 SPLOST funding.

Council considered bids and award of purchase of ruggedized laptop/docking stations for the Thomasville Police Department. It was noted this item was not discussed in Workshop due to time constraints. Chief of Police, Troy Rich reported the 2018 Capital Budget included \$24,840.00 to purchase four (4) ruggedized laptops, two (2) tablets and docking stations for new Police Vehicles. The laptops are Dell Latitude 7414 Rugged Extreme and the tablets are the Surface Pro 4. The docking stations for all equipment is made by Havis. Chief Rich reported the IT Department received quotes from CDW-G and Network Technology Solutions. Network Technology Solutions was recommended as the supplier of the Dell Latitude 7414 Rugged Extreme laptops and docking stations. CDW-G was recommended for the tablets and docking stations. Chief Rich noted that this type of equipment allows officers to complete necessary reports while in the field, thus reduce time spent behind desks. The total costs received as follows, with Docking Stations:

On motion of Councilmember Mobley, and seconded by Councilmember Flowers, Council unanimously awarded the purchase of four (4) Dell Rugged Extreme Laptops with Havis Docking Stations from and two (2) Surface Pro 4 Tablets and Havis Docking Stations from, with third party financing if necessary.

Mayor Hobbs reported that was the conclusion of the printed agenda. Councilmembers commended the community for their participation and attendance. Councilmember reported construction at Cherokee Lake Park is progressing and could be completed mid-July, depending upon weather conditions.

Mayor Pro Tem Scott addressed those present. Referring to recent actions, he noted trust of Council by citizens had been broken. Mayor Pro Tem Scott further noted this trust could be rebuilt with accountability, transparency and oversight. He acknowledged the previous statement was easy to make and difficult to complete. Mayor Pro Tem Scott reported by law of the City Charter it is the responsibility of Council to govern the City of Thomasville and manage it financially. Mayor Pro Tem Scott noted the goal of this address was to let citizens know their warranted and increased concerns have not gone unnoticed. He concluded by citing II Corinthians, 4:8-9, noting this can be overcome and should not be allowed to stop the City's ability to move forward.

Having no further discussion, Mayor Hobbs adjourned the meeting at 6:55 PM.
