

## City of Thomasville Council Meeting, February 10, 2020

The Council of the City of Thomasville met in regular session with Mayor Greg Hobbs presiding and the following Councilmembers present: Mayor Pro Tem David Hufstetler; and Councilmembers Jay Flowers, Todd Mobley and Wanda Warren (Councilmember Warren participated in the meeting by teleconference). Also present was the City Manager, J. Alan Carson; City Attorney, Tim Sanders; other staff, members of the press and citizens. The meeting was held in Council Chambers at 144 East Jackson Street, Thomasville, Georgia.

### CALL TO ORDER

Mayor Greg Hobbs called the meeting to order at 6:00 PM and reported Councilmember Warren would participate in the Council meeting by teleconference.

### INVOCATION

Given by Councilmember Jay Flowers.

### PLEDGE OF ALLEGIANCE

Mayor Pro Tem David Hufstetler led the Pledge of Allegiance.

### APPROVAL OF MINUTES

Councilmember Flowers motioned to approve the minutes of the regular City Council Meeting of January 27, 2020 as presented. Councilmember Mobley seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

### PRESENTATIONS

There were no special presentations given at this meeting.

### CITIZENS TO BE HEARD

Mayor Hobbs acknowledged the following citizens as listed on the Citizens to be Heard sign in sheet:

1. Ernest Nixon, 121 Pheasant Ridge, Thomasville, Georgia, addressed Council regarding his concerns with the Weston Park project. He noted the process was taking longer than the Douglas Alumni Association had anticipated and the Park and adjacent Football field should be approached as two separate projects. It was noted that funding from SPLOST has been set aside; however, the funding is not received all at once and an agreeable insurance option has not been confirmed to date. City Manager will provide Mr. Nixon with additional information prior to Douglas Alumni Association's meeting later in the week.
2. Terry Scott, 106 Pinecrest Boulevard, Thomasville, Georgia, also addressed Council regarding his concerns of the time it has taken to see progress at Weston Park. There were further comments regarding funding and the overall process of projects and completion in general. Scott commended the Council and City Staff for their efforts in producing successful events celebrating Black History in Thomasville.
3. Keith Thomas, 432 Woods Gate Lane, Thomasville, Georgia, addressed Council with his concerns regarding the need for a public community pool in the area of the Thomasville Dog Park. There was brief discussion regarding public transportation recreation needs. Mayor Hobbs suggested Thomas address this request to the Recreation Advisory Board at their next meeting.

**ADOPT AGENDA**

Councilmember Mobley motioned to approve the agenda as presented, with no exceptions. Councilmember Flowers seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

**OLD BUSINESS**

**Second reading of an ordinance to authorize acquisition of property for Right of Way from Thomas University, Inc. in connection with Pinetree Boulevard Resurfacing Project.**

City Attorney, Tim Sanders, reported there had been no changes from the first reading of this ordinance on January 27, 2020. The purchase of the property owned by Thomas University, Inc. is in connection with and necessary to the planned resurfacing and construction of street and related improvements on the portion of S. Pinetree Boulevard beginning at the intersection of S. Pinetree Boulevard and W. Jackson Street and ending at the intersection of S. Pinetree Boulevard and Old Monticello Road.

Mayor Pro Tem Hufstetler motioned to order the first reading of the ordinance to authorize acquisition of property for Right of Way from Thomas University, Inc. in connection with Pinetree Boulevard Resurfacing Project as read for the second time, passed and adopted as presented. Councilmember Flowers seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

The ordinance read for the second time, passed and adopted follows.

AN ORDINANCE TO AUTHORIZE THE PURCHASE OF THAT REAL PROPERTY DESCRIBED AS PARCEL NO. 1 DESCRIBED ON THAT SURVEY PREPARED BY FRANK E. CARLTON, DATED JULY 26, 2019, CONSISTING OF APPROXIMATELY 7,745 SQUARE FEET, LOCATED AT THE INTERSECTION OF MAGNOLIA STREET AND SOUTH PINETREE BOULEVARD; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR THE EFFECTIVE DATE OF THIS ORDINANCE; AND FOR OTHER PURPOSES.

**SECTION I**

WHEREAS, the City of Thomasville has the opportunity to purchase from Thomas University, Inc. that real property described as Parcel No. 1 described on that survey contained in Exhibit "A," attached hereto and made a part hereof, dated July 26, 2019 ("Survey"), consisting of approximately 7,745 square feet, located at the intersection of Magnolia Street and South Pinetree Boulevard in the City of Thomasville, Georgia (Parcel No. 1 hereinafter being referred as the "Property"); and

WHEREAS, the purchase of the property is in connection with and necessary to the planned resurfacing and construction of street and related improvements on the portion of S. Pinetree Boulevard beginning at the intersection of S. Pinetree Boulevard and W. Jackson Street and ending at the intersection of S. Pinetree Boulevard and Old Monticello Road ("Project");

WHEREAS, the Council of Thomasville, Georgia, recognizes that the purchase of the Property is necessary to and in furtherance of the Project, is a valid public purpose and of significant benefit to the citizens of the City and their health and safety; and

WHEREAS, the purchase of the Property will be a cost effective measure for the goals and objectives in furtherance of the Project.

## SECTION II

NOW, THEREFORE, BE IT ORDAINED by the Council of Thomasville, Georgia, and it is hereby ordained by the authority of the same (i) that the acquisition of the Property, more particularly described on the Survey as Parcel No. 1 contained in Exhibit "A" attached hereto and made a part hereof, is hereby authorized for a purchase price of Ten Thousand Three Hundred Seventy Eight and 34/100 Dollars (\$10,378.34); (ii) that the documents attached hereto and incorporated herein as Exhibit "A" are hereby ratified and approved; (iii) that the Mayor is authorized to take all actions and to do all things necessary to carry out the purposes and intent set forth in this ordinance and to effect the purchase of the Property, under such other terms and conditions as may be necessary and appropriate in his judgment and discretion, in consultation with the City Attorney, including but not limited to the execution of settlement statements and other related closing document; and (iv) that the forgoing (i-iii) are conditioned upon and subject to satisfactory title exam concerning the Property in the judgement of the Mayor in consultation with the City Attorney.

## SECTION III

BE IT FURTHER ORDAINED that this ordinance shall become effective immediately upon its final adoption.

## SECTION IV

BE IT FURTHER ORDAINED that the provisions of this ordinance shall not be made a part of the official codified ordinances of the City of Thomasville but will nevertheless be spread upon the public minutes and records of the City of Thomasville.

## SECTION V

This ordinance was introduced and read at a lawful meeting of the Council of Thomasville, Georgia, held on January 27, 2020, and read a second time, passed, and adopted in a like meeting held on February 10, 2020 and passed on first and second reading of the ordinance at that same meeting.

## NEW BUSINESS

### **First reading of an ordinance to amend text of Chapter 5 Building Construction to ensure compliance with minimum mandatory codes as set forth by the Department of Community Affairs.**

Chief Building Official, Mark Harmon, presented. Georgia's uniform construction codes are designed to help protect the life, health, and property of all Georgians from the hazards of faulty design and construction; unsafe, unsound, and unhealthy structures and conditions. Currently mandated Codes can be found on the Department of Community Affairs (DCA) website and with the Georgia State Fire Marshall's office. As of January 1, 2020, the code editions have been updated and the roster of mandatory codes has been expanded. Within the City of Thomasville ordinances, we reference and have adopted all 10 of 11 of mandatory codes and 2 of the permissive codes (IPMC and IEBC). The language of the text however is not consistent and references older codes in some cases. The newly minted mandatory code (ISpsc) for swimming pools needs to be adopted to replace the previous combination of 1991 Standard Swimming pool code along with locally written restrictions on pools. To align fully with the mandated codes established by the State of Georgia and as described on the DCA website, the text within our ordinances in Chapter 5, captioned "Building Construction", sections 5-12, 5-13, 5-14, 5-31, 5-81, 5-106, 5-171, 5-216, 5-265, 5-266, 5-401 must be amended. Changes that state in each section "as adopted by the State of Georgia with Georgia State Amendments, and including any chapters(s) pertaining to Administration and appendices" are recommended so as to resolve the process of future text amendments for the next several code cycles. It was noted that the City of

Thomasville is not adopting any new code type that was not previously referenced within our ordinances. These amendments are clarifying language to agree with the mandates of the State.

Additionally, Harmon presented for consideration a modified section pertaining to pool discharge. The Environmental Protection Division (EPD) of Georgia does not allow discharge of water with elevated levels of chlorine into the storm water system. Currently City of Thomasville Code Chapter 5, Section 266 states “*water may be discharged into a storm sewer provide permission is obtained from the City Engineer*”. The Engineering department feels the best resolution is to direct any discharge of pool water into the sanitary sewer system.

It was recommended by City Staff (Chief Building Official, Code Enforcement Officer, Fire Marshall, and Right of Way Superintendent), text shall be modified as presented, so as to align with Georgia State Statute and EPD.

Councilmember Mobley motioned to order the second reading of the ordinance to amend text of Chapter 5 Building Construction to ensure compliance with minimum mandatory codes as set forth by the Department of Community Affairs, read for the first time, passed and carried over as presented. Councilmember Flowers seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

The ordinance title to amend Chapter 5, captioned “Building Construction” read for the first time, passed and carried over follows.

AN ORDINANCE TO AMEND SECTIONS OF CHAPTER 5 OF THE CODE OF ORDINANCES, CITY OF THOMASVILLE, GEORGIA TO ADOPT CERTAIN STANDARDIZED CODES AS ADOPTED BY THE STATE OF GEORGIA; TO PROVIDE FOR AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

**First reading of an ordinance to amend text of Chapter 12 Public Safety to ensure compliance with minimum mandatory codes as set forth by the Department of Community Affairs.**

Chief Building Official, Mark Harmon, presented. Georgia’s uniform construction codes are designed to help protect the life, health, and property of all Georgians from the hazards of faulty design and construction; unsafe, unsound, and unhealthy structures and conditions. Councilmember Mobley seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

The ordinance title to amend Chapter 12, captioned “Public Safety” read for the first time, passed and carried over follows.

AN ORDINANCE TO AMEND SECTION 12-71 OF CHAPTER 12 OF THE CODE OF ORDINANCES, CITY OF THOMASVILLE, GEORGIA TO ADOPT THE INTERNATIONAL FIRE CODE AS ADOPTED BY THE STATE OF GEORGIA WITH GEORGIA STATE AMENDMENTS, INCLUDING ANY CHAPTER(S) PERTAINING TO ADMINISTRATION AND APPENDICES INCLUDED IN THE INTERATIONAL FIRE CODE BUT NOT ADOPTED BY THE STATE OF GEORGIA; TO PROVIDE FOR AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

**Consider actions for Hazard Mitigation Grant Program Application as listed.**

Executive Director-Public Utilities, Chris White, presented. The Hazard Mitigation Grant Program (HMGP) is a federally funded program that provides funds to grantees to facilitate the protection of life and property against man-made and natural disasters by directing the state's efforts in the areas of prevention, preparedness, mitigation, response and recovery. One objective of the HMGP is to enable mitigation measures to be implemented during the immediate recovery from a disaster. The City of Thomasville is requesting authorization to submit an HMGP application for funding for projects to install generators at critical facilities to include; Fire Station #2 (2), Fleet Services; maintenance building and CNG slow-fill station, Lift Stations (3). Each facility is critical to the immediate recovery of our community during and after natural disasters and met the required power outage during Hurricane Michael. It was noted that commitment of matching funds of 15% is required and, if awarded, will be used for projects in the FY2021.

Councilmember Flowers motioned to approve the submission of Hazard Mitigation Grant Program Application, to authorize the Mayor as the signatory for necessary and related documents and a resolution to authorize City of Thomasville's commitment of required matching funds. Councilmember Mobley seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

**Resolution to approve Citizen Board Appointments for Boards, Commissions and Authorities.**

Mayor Greg Hobbs reported citizens appointed to Boards, Commissions and Authorities are appointed for various term lengths and when those terms are vacated or expired, it is the responsibility of the City Council to appoint or re-appoint citizens. Individual citizen names were read as listed as Exhibit "A" and included as an attachment to the resolution of appointment.

Mayor Pro Tem Hufstetler moved to approve the resolution appointing individuals for Boards, Commissions and Authorities as presented. Councilmember Flowers seconded. Councilmember Warren inquired of the omission of the third individual to be appointed to the Tree and Landscape Board. Mayor Hobbs acknowledged the omission and reported the appointment will be made by resolution at a subsequent Council meeting. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

At a regular meeting duly publicized and open to the public, there being a quorum of the City Council of the City of Thomasville, Georgia (the "City Council") present, the City Council takes the following actions and adopts the following resolutions:

RECITALS:

WHEREAS, the City Council is vested with the authority to appoint persons to various boards, commissions, and authorities and the City Council desires to exercise such authority.

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. Incorporation of Recitals. The Recitals set forth above are incorporated herein by this reference as if set forth fully in this Section 1.

Section 2. Appointment. The City Council hereby appoints those persons listed on Exhibit A attached hereto and made a part hereof to the boards, commissions and authorities as set forth on Exhibit A. The appointments set forth on Exhibit A to such boards, commissions and authorities shall be for the terms as provided for in the ordinance, resolution, legislative act or such other applicable governing organizational document for each such board, commission and authority.

Section 3. Actions Approved and Confirmed. All acts and doings of the City Council, the Mayor, Mayor Pro Tempore, the officers and employees of the City that are in conformity with the purposes and intents of this Resolution and in the furtherance of appointments described and authorized herein shall be, and the same hereby are, in all respects approved and confirmed.

Section 4. Severability of Invalid Provisions. If any one or more of the provisions herein contained shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separable from the remaining agreements and provisions and shall in no way affect the validity of any of the other agreements and provisions hereof or of the actions authorized or ratified hereunder.

Section 5. Repealing Clause. All resolutions or parts thereof in conflict with the provisions herein contained are, to the extent of such conflict, hereby superseded and repealed.

Section 6. Effective Date. This resolution shall be effective immediately upon its adoption.

**Motion to approve a One-Day Alcohol Event Permit for annual “OakFest” event scheduled for March 14, 2020 at The Ritz Amphitheater.**

Tax & Licensing Manager, Emily Phillips, presented. The Children’s Treehouse Advocacy Center of Thomas County, Inc. has submitted a completed City of Thomasville Application for a One-Day Permit for Sale of Alcoholic Beverage by Bona Fide Charitable & Non-Profit Civic Organization (Consumption Only) for the annual fundraising event “OakFest” to be held at The Ritz Amphitheater in downtown Thomasville on March 14, 2020, from 4:00 PM until 10:00 PM. City Council approval of the One-Day Alcohol permit is required as the event will be held on property owned by the City. The Thomasville Police Department found no reason not to issue the One-Day Alcohol permit.

Mayor Pro-Tem Hufstetler motioned to approve the One-Day Alcohol Event Permit for the Children’s Treehouse Advocacy Center of Thomas County, Inc. as presented. Councilmember Flowers seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

**Motion to approve Alcohol License for Retail Package Beer and Wine for J & B’s Country Meats.**

Tax & Licensing Manager, Emily Phillips, reported applicant Robert Jones, owner of J & B Meats, is requesting approval for License to Engage in the Business of Package Beer and Wine for J & B Meats, located at 2780 East Pinetree Boulevard, Thomasville, Georgia. Phillips reported the applicant has completed proper procedures and has completed all applications for paperwork. It was noted the background investigation revealed no issues or concerns with the request.

Mayor Pro Tem Hufstetler motioned to approve the License to Engage in the Business of Package Beer and Wine for the location as presented. Councilmember Mobley seconded. There was no further discussion. The motion passed 5-0, with the following votes recorded:

AYES: Mayor Hobbs, Mayor Pro Tem Hufstetler and Councilmembers Flowers, Mobley and Warren.

Following the approval of the License to Engage in the Business of Package Beer and Wine for the location as listed, Mayor Hobbs provided Mr. Jones with a complete copy of Chapter 3, Alcoholic Beverages, of the City of Thomasville’s Municipal Code and stated the following:

“It is important that you and your staff strictly adhere to the City of Thomasville’s Alcoholic Beverage Sales ordinances and required employee training programs. It is important that you have a training program for your employees regarding the sale of alcoholic beverages to underage persons, and it is important that you have written proof that your employees have participated in the required training program. As a reminder, the Thomasville Police Department routinely conducts a “Mystery Shopper Program” so as to monitor the enforcement of the prohibition of sales of alcohol to underage persons. If you or one of your employees sells alcoholic beverages to an underage person through the Mystery Shopper Program, you will be required to appear before the City Council and show written proof that your employees have participated in the required training program. Please understand that the penalties for the sale of alcoholic beverages to underage person are significantly greater if you don’t have written proof that your employees have participated in the required training program. We are providing you with this copy of Thomasville Municipal Code Chapter 3, Alcoholic Beverages, with the added Article V ordinance amendment for “Sale Off-Premises for Catered Functions”. Please familiarize yourself with the code and the requirements associated with your alcoholic beverage license.”
