The Council of the City of Thomasville met in regular session on the above date. Mayor Jay Flowers presided and the following Councilmembers were present: Mayor Pro Tem Todd Mobley and Councilmembers Wanda Warren, Terry Scott, and Scott Chastain. Also present were the City Manager, J. Alan Carson; Assistant City Managers, Sheryl Sealy and Chris White; City Attorney, Tim Sanders; other city staff; citizens and members of the media. The meeting was held in Council Chambers at City Hall, located at 144 East Jackson Street, Thomasville, Georgia. Simultaneous access to the meeting was provided to those members of the press and citizens not present via the City of Thomasville's online live stream feed located at www.thomasville.org.

CALL TO ORDER

Mayor Flowers called the meeting to order at 6:00 PM.

INVOCATION

Councilmember Scott gave the invocation.

PLEDGE OF ALLEGIANCE

Mayor Pro Tem Mobley led the Pledge of Allegiance.

APPROVAL OF MINUTES

Mayor Pro Tem Mobley motioned to approve the City Council Regular Meeting Minutes of December 12, 2022, as presented. Councilmember Warren seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

PROCLAMATIONS / RECOGNITIONS

- 1. Mayor Flowers acknowledged Mr. Len Robinson, owner of WPAX Radio Station; the third oldest station in Georgia. Mayor Flowers presented to Mr. Robinson a proclamation honoring WPAX Radio Station for its service to the community for over 100 years. WPAX was founded by Hoyt Wimpy on December 27, 1922. Mr. Robinson, affectionately known in the community as "LenRob", began working at the station when he was just 15 years old and is the fourth owner. Mr. Robinson thanked Councilmembers for their recognition and the community for its support for over a century.
- 2. Thomasville Police Department Chief John Letteney recognized the date as National Law Enforcement Appreciation Day and commended all law enforcement personnel for serving and protecting their communities. Chief Letteney presented recognition awards to officers administering lifesaving aid and assisting with crime scene investigations, preventing death and acting as guardian angels to victims in their time of need. Life Saving and Grand Cordon Awards were presented to Lieutenant Jason Baldwin, Corporal Casey Kin, Officer Brandon Burden, Officer Benjamin Harrison, Officer Melvin Ray, and Officer Leornard Angel. Officer Ray also received an award for Meritorious Service. Chief Letteney also recognized Sergeant Adam Lawson and the nominations committee for their efforts in the process of recognizing personnel of the Thomasville Police Department and their dedication and service to their community.
- 3. Mayor Flowers recognized Elisabeth Ouzts, permit technician for the City of Thomasville, for her accomplishments in competing in the 2022 Spartan World Trifecta Championship held in Sparta, Greece. Ouzts competed in the three day championship, coming in tenth, and third out of the USA competitors. Ouzts thanked "The Coffee Table Team", for being her biggest cheerleader and helping her to fund the trip and participation in championship.

CITIZENS TO BE HEARD

1. Lucinda Brown, resident of Halcyon Way, Thomasville, Georgia voiced concerns about the City of Thomasville providing American Rescue Plan Act (ARPA) funding to the Community Outreach Center and its requirement of providing "matching funds" to be distributed. Brown noted this money cannot be accessed

- by the people who need it because they cannot provide matching funds. She requested an explanation be given which provides for the City to require matching funds for the money to be distributed to those in need.
- 2. Keith Thomas, resident of Woods Gate Lane, Thomasville, Georgia, voiced concerns regarding CSX Railroad schedule that allows trains to paralyze the City several times during the day. He noted the current train schedule provides increased safety concerns for traffic, safety vehicles and the general public; especially when it is oftentimes stopped completely for long periods of time. He further noted with only two overpasses to circumnavigate the stopped train, traffic become jammed quickly and emergency vehicles experience great difficulty navigating the normal routes to the hospital.

ADOPT AGENDA

Mayor Pro Tem Mobley motioned to adopt the agenda as presented. Councilmember Chastain seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

OLD BUSINESS

Second reading of four separate ordinances to authorize the acquisition of utility and permanent easements in connection with the Old Albany Road Sidewalk Project (GDOT PI#0015394).

City Attorney, Tim Sanders reported there has been no changes to the ordinances since their individual passages on first reading. It was noted that each ordinance shall be considered individually and with a separate vote of each from Council.

 Parcel 8: Second reading of an ordinance to authorize the acquisition of a permanent easement for construction and maintenance of slopes and drainage of approximately 3,566.66 square feet located from James Thomas Rehberg at 507 Old Albany Road is necessary for furtherance of the Old Albany Road Sidewalk Project. The consideration paid will be Five Hundred Dollars (\$500.00) and the easement will vest in the City and will later be assigned to the Georgia Dept. of Transportation.

Councilmember Chastain motioned to order the second reading of the ordinance authorizing the acquisition of easement in relation to Parcel 8 as read for the second time, passed and adopted as presented. Councilmember Warren seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

The adopted ordinance shall be included in the permanent record of Council Meeting Minutes.

2. Parcel 11: Second reading of an ordinance to authorize the acquisition of a permanent easement for construction and maintenance of slopes and drainage of approximately 153.43 square feet located and a utility easement for the City of approximately 733.00 square feet from Rena Montgomery at 591 Old Albany Road is necessary for furtherance of the Old Albany Road Sidewalk Project. The consideration paid will be Five Hundred Dollars (\$500.00) and the construction and maintenance easement will vest in the City and will later be assigned to the Georgia Dept. of Transportation. Approximately 886.43 combined square feet located at 591 Old Albany Road.

Councilmember Scott motioned to order the second reading of the ordinance authorizing the acquisition of easement in relation to Parcel 11 as read for the second time, passed and adopted as presented. Mayor Pro Tem Mobley seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

The adopted ordinance shall be included in the permanent record of Council Meeting Minutes.

3. Parcel 19: Second reading of an ordinance to authorize the acquisition of a permanent easement for construction and maintenance of slopes and drainage of approximately 488.61 square feet located and a utility easement for the City of approximately 642.63 square feet from Margaret Deuane Duncan at 106 Highland Street is necessary for furtherance of the Old Albany Road Sidewalk Project. The consideration paid will be Five Hundred Dollars (\$500.00) and the construction and maintenance easement will vest in the City and will later be assigned to the Georgia Dept. of Transportation.

Councilmember Warren motioned to order the second reading of the ordinance authorizing the acquisition of easement in relation to Parcel 19 as read for the second time, passed and adopted as presented. Councilmember Scott seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

The adopted ordinance shall be included in the permanent record of Council Meeting Minutes.

4. Parcel 29: Second reading of an ordinance to authorize the acquisition of a permanent general utility easement of approximately 1,872.82 square feet located from David M. Ley and Laura J. Ley at 601 Old Albany Road is necessary for furtherance of the Old Albany Road Sidewalk Project. The consideration paid will be Seven Hundred Three Dollars (\$703.00) and the easement will vest in the City.

Mayor Pro Tem Mobley motioned to order the second reading of the ordinance authorizing the acquisition of easement in relation to Parcel 19 as read for the second time, passed and adopted as presented. Councilmember Scott seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

The adopted ordinance shall be included in the permanent record of Council Meeting Minutes.

Second reading of an ordinance to amend various sections of Thomasville's Code to provide uniformity regarding service on certain boards and commissions, with respect to appointment, attendance, training and removal of members.

City Attorney, Tim Sanders reviewed amendments made to the ordinance since its passage on first reading. The changes effected by this ordinance will generally apply to all of the boards and commissions outlined in section 2-101(a). The exception is that the vacancy and removal provisions do not apply to members of the Pension Board who are elected by the employees. City Attorney Sander reported the boards and entities listed in section 2-101(b) were not solely created by an act of the City. The ordinance applies to those members who are appointed to the boards and commission enumerated in section 2-101(a), and not to councilmembers or ex-officio members set by City ordinance.

Councilmember Scott motioned to order the ordinance to amend Thomasville's Code to provide uniformity regarding service on certain boards, commissions and like bodies as presented as read for the second time, passed and adopted. Mayor Pro Tem Mobley seconded. There was no discussion. The motion passed 5-0, with the following votes recorded; AYES: Flowers, Mobley, Warren, Scott and Chastain.

The adopted ordinance shall be included in the permanent record of Council Meeting Minutes.

Second reading of an ordinance to authorize acquisition of 1,827 square feet located at 1020 Remington Avenue in connection with the Remington Avenue Project.

Executive Director of Engineering and Inspections, Mark Harmon reported there had been no changes since the passage of the ordinance on first reading.

Mayor Pro Tem Mobley motioned to order the ordinance authorizing acquisition of a portion of property located at 1020 Remington Avenue as read for the second time, passed and adopted, as presented. Councilmember Chastain seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

The adopted ordinance shall be included in the permanent record of Council Meeting Minutes.

NEW BUSINESS

First reading of an ordinance to set candidate qualifying fees for the 2023 Municipal General Election.

City Clerk, Felicia Brannen reported pursuant to O.C.G.A. § 21-2-131 et. seq., the Municipal General Election Qualifying Fees are required to be fixed, and published, no later than February 1st of each election year. The qualifying

fee shall be 3% of the total gross salary of the office paid in the preceding calendar year including all supplements authorized by law if a salaried office. If not a salaried office, a reasonable fee shall be set by the governing authority of such county or municipality, such fee not to exceed 3% of the income derived from such county office by the person holding the office for the preceding year; or, not more than \$35.00 for a municipal office. Councilmember Candidate Qualifying Fee shall be set at \$607.68. City School Board of Education member Candidate Qualifying Fee shall be set at \$35.00. The Municipal General Election will be held November 7, 2023 for two councilmember seats and four City Board of Education seats.

Councilmember Warren motioned to order the ordinance to set the qualifying fees for the municipal general election as read for the first time, passed and carried over as presented. Councilmember Scott seconded. Councilmember Chastain inquired if this was the same as previous years. City Clerk Brannen indicated the fees were based upon the salary of the office, which have had no changes since the municipal general election in 2021. There was no further discussion. The motion remained unchanged. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

The ordinance title read for the first time, passed and carried over follows.

AN ORDINANCE TO ESTABLISH THE CANDIDATE QUALIFYING FEES FOR THE 2023 MUNICIPAL ELECTION; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

Motion to approve active 2023 Alcohol Beverage License Renewals.

Customer Service Manager, Melissa Creel reported that all active 2023 alcohol beverage license holders have paid in full their renewal fees for Package Beer and/or Wine; Package Beer, Wine, and Liquor; Consumption of Beer and/or Wine; Consumption of Beer and/or Wine & Liquor Pouring; Consumption Beer, Wine & Liquor Pouring for Private Club only; Catering License for Beer, Wine and Liquor Pouring, Manufacturer Distillery and Manufacturer Brewery.

Motion to approve Asset Disposition Services Agreement for Thomasville Police Department.

TPD Major, Wade Glover reported the Thomasville Police Department manages evidence for Thomasville Police Department, Thomas County Sheriffs' Office, and Thomasville-Thomas County Narcotics Vice Unit. Due to managing evidence for so many agencies, over 5,000 pieces of evidence are collected annually. The evidence includes items such as drugs, guns, construction tools, lawn equipment, televisions, computers, vehicles, clothing, bicycles, and etc. Once the criminal case has been disposed of through the court process, TPD personnel have the daunting task of removing and destroying the remaining evidence after the retention schedule has been met. Items such as narcotics are destroyed in an incinerator. However, other items such as tools, televisions, computers, bicycles, guns, vehicles, and lawn equipment have to be returned to the owner if they can be located, or destroyed. PropertyRoom.com assists law enforcement agencies in the disposal of unwanted evidence in a much more efficient way. The law enforcement agency enters into agreement with PropertyRoom.com who will then retrieve the evidence released by the agency after it has been approved for destruction by the proper court processes. PropertyRoom.com will come in and dispose of all unclaimed property within the custody of the department and the law enforcement agency retains 50% of the proceeds collected. It was noted there was no funding from the City of Thomasville required.

Mayor Pro Tem Mobley motioned to approve the Asset Disposition Services Agreement by and between the City of Thomasville for the Thomasville Police Department and PropertyRoom.com; and, to authorize the Mayor's signature on any necessary and related documents. Councilmember Warren seconded. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

REPORTS

Councilmembers collectively wished the best of luck to the Georgia Bulldogs in the upcoming 2023 College Football National Championship game. Councilmembers also thanked those recognized this evening for their service to the community.

Councilmember Warren reported February is designated and recognized as Black History Month and encouraged citizens to attend events surrounding the designation.

Councilmember Chastain recognized honorary councilmember Austin Williams, and thanked him for his interest in local government.

ADJOURNMENT

Having no further business to discuss, the Thomasville City Council Meeting was adjourned at 6:38 PM.
