Councilmember Terry Scott gave the Invocation.

PLEDGE OF ALLEGIANCE

Mayor Pro Tem Todd Mobley led the Pledge of Allegiance.

APPROVAL OF MINUTES

Councilmember Warren moved to approve the regular meeting minutes of December 11, 2023, as presented. Councilmember Scott seconded the motion. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Flowers, Mobley, Warren, Scott and Chastain.

PROCLAMATIONS

Proclamations Honoring Outgoing Councilmembers

- 1. Councilmember Chastain honored Mayor John H. "Jay" Flowers by presenting a Proclamation acknowledging his years of service to the community as a City of Thomasville Councilmember. City Attorney Sanders then administered the Oath of Office required by Section 2.20 of the Charter of the City of Thomasville to newly elected Councilmember Baker, with his family and friends present. NEW BUSINESS

Motion to approve renewal of City of Thomasville's Guaranty on the Downtown Development Authority Loan with Thomasville National Bank and to authorize the Mayor to sign necessary and related documents.

Chief Financial Officer, Ashley Cason reported that in December 2001, the Downtown Development Authority (DDA) purchased 403 North Broad Street. At that time, the DDA obtained a loan from Thomasville National Bank, which was guaranteed by the City of Thomasville. Each year, the city renews that guaranty on the loan. In August 2005, the DDA entered into a 20-year lease agreement with the Georgia Department of Labor to lease 403 Broad Street for \$222,000 annually (\$18,500 monthly). This lease is for a one-year term, renewable for up to 20 years. The Department of Labor has renewed the lease every year to date. The rental income from this lease is used to pay the loan and maintenance on the building. Currently, the loan balance is \$1,228,414.29. In 2023, the interest rate was 4.90%. For 2023, the interest rate will be 5.80%. The monthly payments will continue to be \$16,000. Again, these monthly payments are funded by the \$18,500 monthly rental payments that DDA receives from the Georgia Department of Labor to lease the building. The City Council only needs to approve a guaranty each year for this loan (like what has been done in the past).

Councilmember Chastain moved to approve the renewal of the City's Guaranty on the DDA Loan with Thomasville National Bank and to authorize the Mayor to sign necessary and related documents as presented. Councilmember Brown seconded the motion. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, Brown and Baker.

Motion to approve Alcohol Beverage License Renewals for 2024.

Customer Service Manager, Melissa Creel reported that all active 2024 alcohol beverage license holders have paid in full their renewal fees for Package Beer and/or Wine; Package Beer, Wine, and Liquor; Consumption of Beer and/or Wine; Consumption of Beer and/or Wine & Liquor Pouring; Consumption Beer, Wine & Liquor Pouring for Private Club only; Catering License for Beer, Wine and Liquor Pouring; Manufacturer Distillery and Manufacturer Brewery.

Councilmember Brown motioned to approve the listing of 2024 Alcohol Beverage License Renewals as presented. Councilmember Chastain seconded the motion. It was noted there were approximately 250 licenses to be renewed annually. There was no further discussion. Customer Service Manager, Melissa Creel reported Anna Bich Truong, *Nail Art by Anna*, at 15068 US Highway 19 South, has applied for a Wine Consumption License. It was noted that the applicant has been through the proper procedures and has completed all applications and paperwork for approval. This license issued by the City is conditioned upon the applicant obtaining a like permit from the Georgia Department of Revenue, Alcohol, and Tobacco Unit.

Bids and award for the purchase of Sidewalk Improvements.

City Engineer, Todd Powell reported the City's sidewalk plan endeavors to enhance pedestrian connectivity to numerous locations within the City limits. A need for a five-foot-wide sidewalk has been identified for Weston Park to receive a connection to Martin Luther King Drive. Also, a sidewalk along South College will provide sidewalk connectivity to Harper Schools for Magnolia Street residents. In addition, sidewalk adjustments will be provided to improve vehicular access to properties along Metcalf Avenue. This sidewalk project includes furnishing all labor, equipment and materials to perform the following work:

- This project consists of improvements to Felix Street to remove a five-foot-wide portion of the existing road asphalt, base, concrete curbs, and gutters. Next, the installation of a five-foot-wide concrete sidewalk, curb and gutter, and sod will occur.
- Installing a five-foot-wide sidewalk on South College Street between Wright and Magnolia Streets.
- Demolition and reconstruction of seven concrete driveways along Metcalf Avenue between East Hill and Simeon Streets.

The work is to be completed within sixty calendar days from the Notice to Proceed date. The 2024 budgeted amount for this Sidewalk Project is \$305,177.00. The work will be funded utilizing SPLOST funds. A summary of bids received follows.

Mayor Pro Tem Scott seconded the motion. Discussion ensued regarding the route locations of the sidewalk when installed; a Location Map of the project areas was reviewed. It was noted that the portion of sidewalk to be installed on Felix Street would require a portion of the road to accommodate the sidewalk installation. There was no further discussion. The motion passed 5-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, Brown and Baker.
