CITIZENS TO BE HEARD

Mayor Mobley acknowledged the following citizen as listed on the Citizens to be Heard Sign-In Form:

- 1. Nate Tyler, president of the Thomas County Branch of NAACP (National Association for the Advancement of Colored People) and resident of Cloverdale Drive, Thomasville, Georgia, voiced concerns regarding the Drug Squad. He noted citizens need to know there is transparency and accountability for this group. Citizens need a way to file complaints regarding how their practices and habits are affecting the community. Mr. Tyler voiced additional concerns regarding Councilmembers' apparent lack of knowledge of the operations of the Drug Squad. Mr. Tyler noted he would be presenting the same concerns to the Thomas County Board of Commissioners.
- Udi Arzi, resident of Artzi Drive, Thomasville, Georgia, voiced concerns of the recent increases in sewer
 tapping fees. He noted the increase in such fees will have an extreme adverse effect on his real estate
 development business with multiple projects underway.
- 3. Candee Henderson, resident of Thomas County, Georgia, voiced concerns regarding the City of Thomasville's actions to encourage people to move to using more natural gas in their homes. She noted they should be considering actions that would encourage 100% renewable energy initiatives, reduce their use of fossil fuels and that would transition the city to 100% renewable energy by 2035.
- 4. Jennifer Dyson, 500 W. Calhoun Street, voiced concerns regarding phone calls and meetings that she has had with City staff resulting in unresolved issues and concerns regarding her property and business prospects at 500 W. Calhoun Street. She noted all phones used by city staff should have recording devices so that conversations could be recorded to avoid staff lying about the conversations held during these calls.

NEW BUSINESS

Resolution to accept grant award from the Office of the Secretary of Transportation (DOT) Safe Streets for All (SS4A) Grant Program.

City Planner, Kenny Thompson reported the <u>Bipartisan Infrastructure Law</u> (BIL) establishes the new Safe Streets and Roads for All (SS4A) discretionary program that will provide \$5-6 billion in grants over the next 5 years. Funding supports regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. The SS4A program supports Secretary of Transportation Pete Buttigieg's <u>National Roadway Safety Strategy</u> and a goal of zero deaths and serious injuries on our nation's roadways. This project is a complement to the Multimodal Transportation Plan (MMTP). The project will focus on the West Jackson Street corridor from Pinetree Blvd to Remington Ave./N. Lee St. With increased residential and commercial development in this corridor there is a need to proactively provide safety for our residents in this already busy area. The project will allow staff to conduct planning, design, and development activities in support of a Comprehensive Safety Action Plan. The specific project will be determined based on data collected, citizen input, and recommendations from the MMTP. Project details will follow in FALL 2024. A 20% match is required for the grant. A total of \$50,000 has been allocated in the FY2024 budget toward the SS4A grant award. This match will be covered by staff and volunteer's time as in-kind services. It was noted that any subsequent projects and proposals relating to the demonstration project will be presented to Council.

Councilmember Chastain moved to adopt the resolution to accept the grant award as presented. Councilmember Baker seconded the motion. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Thomasville, Georgia, hereby authorizes the acceptance of the DOT SS4A grant award in the amount of \$175,000; and,

BE IT FURTHER RESOLVED that the Council of the City of Thomasville, Georgia, further authorizes the Mayor or Mayor Pro Tempore of the City of Thomasville, as the signatory on all necessary and related documents as shall be necessary in relation to the DOT SS4A grant award.

Motion to approve Budget Amendment FY 2023.

Chief Financial Officer, Ashley Cason reported that each year, the City of Thomasville is required to obtain approval to amend the budget for any Funds with revenues and expenditures/expenses that exceed the budget. Like prior years, we wait until the year end is over and present to the Council all the final amounts that are required to be amended at one time. Below, is a comparison by Fund Type of the City of Thomasville's Original 2023 Budget versus the Proposed Amended 2023 Budget. This table reflects all operating and capital expenses and transfers.

CFO Cason noted that by far, the Enterprise Funds require the greatest amendment. These amendments consist of adjustments to the Electric, Airport, Broadband, Golf Course, and Landfill Funds. Electric transferred \$2 million to Landfill and spent roughly \$4 million more to cover unforeseen costs in M&R distribution, contract crew expenses, and storm costs. Landfill required roughly \$4 million to cover the unexpected Cell 5B expansion project and the Flare and Methane Well expansion project. The Airport, Broadband, and Golf Course funds all require budget amendments to cover operating expenses that were in direct correlation with the revenues that also exceeded budget.

Councilmember Baker moved to approve the Budget Amendment FY2023, including any necessary audit adjustments, as presented. Councilmember Chastain seconded the motion. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

Motion to authorize the signature of Mayor or Mayor Pro Tem to execute a Hangar Lease Agreement by and between the City of Thomasville and Willis Aviation Aircraft Management, LLC.

Executive Director of Inspections & Engineering, Mark Harmon reported Flowers Industries, Inc. entered into a ground lease with the City of Thomasville beginning in 1983 to construct and maintain an aircraft hangar in support of their aviation program. The lease term was 30 years with allowable extensions to the agreement as needed. In June 2023, Flowers Industries, Inc. submitted a termination agreement stating that they would be abandoning their aviation program and vacating the hangar space. The improvements and structures became property of the City airport at that time. Although the City Council approved fixed fees/rates for existing hangar space at the Airport, this is a unique facility with attributes that other hangars do not possess. An outside third-party appraisal was secured to establish an improvement value and income value based upon comparable structures in the area. Bell, Griffith & Associates, Inc. established a fair market value for improvements of \$890,000.00, and a gross income estimate of \$89,778.00 annually (\$7,481.00 monthly). With this information in hand, City staff were able to negotiate a 10-year term lease agreement for the improvements with Willis Aviation Aircraft Management, LLC. The Lease considers the special attributes, and limits of the existing facility and allows the end user some flexibility with a base rental rate of \$3,500.00 each month and a minimum fuel consumption of 3,000 gallons per month of JetA fuel. The terms of this lease meet the estimated income as established within the appraisal.

Councilmember Chastain moved to authorize the Mayor, or Mayor Pro Tem, to execute a Hangar Lease Agreement by and between the City of Thomasville and Willis Aviation Aircraft Management, LLC, as presented. Mayor Pro Tem Scott seconded the motion. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

Motion to approve Alcohol Beverage License for Retail Consumption of Beer and Wine for Rack's Bar and Grill, 2613 East Pinetree Boulevard, Thomasville, Georgia.

Customer Service Manager, Melissa Creel reported Rack's Bar and Grill, Mellisa Smith, has completed application for License to Engage in the Business of Selling Beer and Wine Consumption at the establishment located at 2613 East Pinetree Boulevard, Thomasville, Georgia. The license is issued by the City is conditioned upon the applicant obtaining a like permit from the Georgia Department of Revenue, Alcohol and Tobacco Tax Unit. Manager Creel further reported the owner had signed the City of Thomasville affidavit relating to the sale of alcohol to underage persons and the owner was made aware of the annual mystery shopper program.

Mayor Pro Tem Scott moved to approve the Alcohol Beverage License for Rack's Bar and Grill as presented. Councilmember Baker seconded. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

Motion to approve One-Day Alcohol Beverage Event Permit for Leadership Georgia event held at *The Ritz Amphitheater*.

Customer Service Manager, Melissa Creel reported that Leadership Georgia has submitted a completed City of Thomasville Application for a One-Day Permit for Sale of Alcoholic Beverage by Bona Fide Charitable & Non-Profit Civic Organization (Consumption Only for Beer, Wine, and Liquor) for the Leadership Georgia event to be held at *The Ritz Amphitheater* in downtown Thomasville on March 2, 2024. City Council approval of the One-Day Alcohol permit is required as the event will be held on property owned by the City. The Thomasville Police Department found no reason not to issue the One-Day Alcohol permit.

Councilmember Chastain moved to approve the Alcohol One Day Event Permit for Consumption of Beer and Wine for Leadership Georgia's event as presented. Councilmember Baker seconded the motion. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

Consider bids and award for the purchase of Thermoplastic Striping of various city streets.

Civil Engineer, Britt Wetherington reported that on May 22, 2023, the City Council passed a resolution to authorize the submittal of an application for the FY2023 Local Maintenance Infrastructure Grant (LMIG) Safety Action Plan (SAP) to obtain funding toward low-cost safety improvements on our roads. Georgia Department of Transportation (GDOT) provided a list of eligible items and 27 applicable city roads based on crash data, and the city submitted a list

of projects based on that guidance. On June 23, 2023, GDOT committed \$298,000 toward our projects, which the city has already received. This project consists of safety improvements in the form of thermoplastic striping to the following streets: Blackshear Street, North Broad Street, South Crawford Street, Edgewood Circle, Fletcher Street, Genesis Parkway, Glenwood Drive, South Madison Street, Magnolia Street, North Martin Luther King Jr. Drive, Neel Street, Old Monticello Road, Park Avenue, Patterson Street, South Street, North Stevens Street, Varnedoe Street, and West Washington Street. These improvements include the refurbishment of existing striping and a minimal amount of new striping on the streets and roads listed above. The Safety Action Plan is primarily funded through the LMIG. As with all LMIG projects, a 30% local match will be required. The total cost for this project, per bid, is \$103,023.55. Of this total, the local share will be \$30,907.07, which has been allocated in the 2024 Budget under the 2018 SPLOST. A summary of bids received follows.

Councilmember Chastain moved to award the bid for the purchase of Thermoplastic Striping of designated city streets, to Mid State Construction and Striping, Inc., as presented. Councilmember Baker seconded the motion. There was a brief discussion regarding the location of the streets. The motion remained unchanged, there was no further discussion. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

Consider bids and award for the purchase of Camera System Replacement.

Director of Information Technology, Michael Reddick reported that as part of the City of Thomasville's commitment to the safety and well-being of its employees, the City installed a camera security system in 2016. Technological advancements have rendered that systems as outdated and less effective in ensuring the safety and security of employees. The initial platform is now at its end-of-life and the version that was recommended to replace it has several issues that are beyond repair. An RFP was compiled and sent to various vendors and five bids were received. Based on the products presented, three of the five were short-listed and asked to provide an additional demo of their proposed products. A summary of proposals received follows.

Director Reddick reported approximately 80% of the currently installed cameras were operational and effective. Staff is requesting that Council consider awarding the bid to JamTek Electrical, LLC, of Macon, Georgia, to supply and facilitate the installation of 220+ cameras of the Verkada camera solution in a two-phased approach, and to authorize the Mayor, or Mayor Pro Tem, to sign all necessary and related documents to execute the contract, as presented. Director Reddick reported the funds were approved in the 2023 capital budget, which carried over to the 2024 budget.

Councilmember Chastain moved to award the proposal to JamTek-Verkada and to authorize the authorize the Mayor, or Mayor Pro Tem, to sign all necessary and related documents to execute the contract, as presented. Councilmember Baker seconded the motion. There was no discussion. The motion passed 4-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, and Baker.

REPORTS

Mayor Mobley, Mayor Pro Tem Scott and Councilmembers collectively commended City Staff, Event Organizers, and the Community for their efforts for the successful Black History Month events.

Mayor Mobley recognized Congressman Sanford Bishop's Field Representative, Paul Fryer, who was in attendance at this meeting and invited him to speak. Mr. Fryer encouraged City Leaders to continue to contact him if there was

anything in which the City of Thomasville had issues or concerns the Congressman Bishop could assist. He commended the community events in celebration of Black History Month.

Councilmember Baker thanked city staff for their patience in answering his multitude of questions regarding agenda items for consideration.

ADJOURNMENT

Having no further business for consideration, the Thomasville City Council Meeting was adjourned at 6:26 PM.
