- (1) It shall be unlawful for any Person to make, continue, or cause to be made or continued any Construction Sound in such a manner so as to be Plainly Audible at a distance of 300 feet or more beyond the Property Line or Boundary of the property from which the Construction Sound emanates (i) between the hours of 7:00 a.m. and 9:00 p.m. Monday through Friday, (ii) and between the hours of 9:00 a.m. and 6:00 p.m. on Saturday and Sunday.
- (2) It shall be unlawful for any Person to make, continue, or cause to be made or continued any Construction Sound on (i) between the hours of 9:00 p.m. and 7:00 a.m. Monday through Friday: (ii) during the period beginning 9:01 p.m. Friday and ending at 8:59 a.m. the following Saturday morning; and (iiiii) between the hours of 6:00 p.m. and 9:00 a.m. on Saturday and Sunday; and (iv) during the period beginning 6:01 p.m. Sunday and ending at 6:59 a.m. the following Monday morning.
- (3) Notwithstanding this prohibition, the City Manager or the City Manager's designee may determine when the loss or inconvenience that would result to any party in interest is of such a nature as to warrant special consideration, in which case the City Manager or the City Manager's designee may grant a permit for a period of time not to exceed fourteen (14) days for Construction work to be done during hours outside of those hours permitted above. The City Manager or the City Manager's designee may grant multiple permits to a party when the loss or inconvenience that would result to any party in interest is of such a nature as to warrant special consideration.
- (4) The prohibitions of this subsection (f) shall not apply to government road, water, sewer, stormwater construction or maintenance projects or to utility company construction or maintenance projects."

NEW BUSINESS

Resolution to accept the commitment of matching funds for the FY 2025 Community Development Block Grant Innovation Application.

Grants Administrator, Pam Schalk, reported that as part of developing the FY2025 CDBG grant application on behalf of Halcyon Home, it became clear that additional funding is needed to provide not only a new family violence shelter, but to also provide childcare and transitional housing for victims of family violence in our region. The CDBG Innovative grant program was determined to be a better fit for the project. The McCall Architectural Firm has provided an updated estimated cost of construction and services. Staff and the Regional Commission have reviewed and approved the budget. The Halcyon Home Board of Directors has accepted the firm's recommendations. DCA-13 form outlines proposed cash and in-kind match. The City Council must accept the Commitment of Matching Funds as part of the application for the FY2025 CDBG Innovative grant on behalf of Halcyon Home for the construction of a new family violence shelter. The grant request will be five million dollars (\$5,000,000). Halcyon Home will provide the required matching funds, and the city will provide audit services in an amount of up to one thousand dollars (\$1,000) and up to three thousand (\$3,000) for legal fees; for a total amount not to exceed \$4,000.00. Staff will provide support as outlined in the Memorandum Of Understanding (MOU) with Halcyon Home. The SW GA Regional Commission will provide services as outlined in the Memorandum Of Agreement (MOA). It was noted that the final amounts for the audit services and legal fees were determined following the receipt of the McCall Architectural Firm's updated estimated cost of construction and services and the fees are required for the services to ensure compliancy.

Councilmember Chastain moved to approve the resolution to accept the commitment of matching funds for the FY2025 CDBG Innovation Application as presented. Councilmember Baker seconded the motion. Mayor Mobley requested that communication of potential additional fees be made known earlier in the process of grant applications. There was no further discussion. The motion passed unanimously 5-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, Baker and Brown.

BE IT FUTHER THEREFORE RESOLVED, City of Thomasville and Freesia Properties will comply with the matching funds requirement of the CDBG grant.

Resolution to award proposal of Cemetery Mowing Contract.

Director of Public Works, Stephen Stewart, reported that the City of Thomasville is responsible for the upkeep and maintenance of 5 Cemeteries, which includes regular mowing and general grounds maintenance to preserve the dignity and appearance of the cemetery grounds. Every 5 years, the city solicits bids from qualified contractors to perform mowing and trimming services. The goal is to ensure the cemetery remains respectful and accessible to the public, particularly during key visitation periods such as Mother's Day, Memorial Day and Veterans Day. A Request for Proposals (RFP) was issued on June 9th, and the bidding period closed on July 9th. The city received 1 bid from C & R Lawn Service of Taylor County in the amount of \$155,000, previous contract amount \$199,900. The submission was evaluated based on cost, experience, capacity to perform the work, references, and responsiveness to the RFP specifications. Following is a summary of RFP's sent, and proposals received.

The following Companies attended on site meeting June 26th: 1) Angry Lawncare; 2) Johnson Lawncare and Landscaping; and, 3) Clen Site Restoration.

It is requested City Council consider a resolution for the bid award and authorize the Mayor or Mayor Pro Tem to execute the contract following the review by the Public Works and Cemetery Departments, we recommend C & R Lawn Service of Taylor County in the amount of \$155,000 as the preferred contractor based on a combination of competitive pricing and demonstrated reliability in providing similar services to the City of Thomasville (Right-of-Ways and Parks contract). Brief discussion ensued regarding claw back provisions should the work not be completed as contracted. It was noted that there is a clause on both sides of the contract to ensure work is completed, as well as

a detailed listing of what services are expected. It was further noted that this is a five-year contract with annual renewals.

Councilmember Chastain moved to approve the resolution awarding the contract to C & R Lawn Services of Taylor County, in the amount of \$155,000 annually. Mayor Pro Tem Scott seconded the motion. There was no discussion. The motion passed 5-0, with the following votes recorded: AYES: Mobley, Scott, Chastain, Baker and Brown.

The adopted resolution follows.

RESOLUTION

WHEREAS the City of Thomasville is responsible for the upkeep and maintenance of five separate Cemeteries, which includes regular mowing and general grounds maintenance to preserve the dignity and appearance of the cemetery grounds; and,

WHEREAS it is the goal of the City of Thomasville's Public Works Department to ensure each of those five cemeteries remain respectful and accessible to the public, particularly during key visitation periods such as Mother's Day, Memorial Day and Veterans Day; and,

WHEREAS the City of Thomasville solicits proposals from qualified contractors to perform mowing and trimming services every five years for the upkeep of the city's five cemeteries; and,

WHEREAS, a Request for Proposals (RFP) was issued on June 9, 2025, with the bidding period closed on July 9, 2025, pursuant to the policies and procedures of the City of Thomasville; and,

WHEREAS there was one Proposal received from C & R Lawn Service of Taylor County for the services requested in the amount of \$155,000; and,

WHEREAS, the City Council for the City of Thomasville, Georgia desires to enter into a one-year contract in the amount of \$155,000.00, with four one-year renewals at the same contract annual amount, with C & R Lawn Service of Taylor County as being most qualified to perform this work.

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. <u>Incorporation of Recitals.</u> The Recitals set forth above are incorporated herein by this reference as if set forth fully in this Section 1.

Section 2. <u>Approval and Authorization of Contract.</u> The City Council for the City of Thomasville, Georgia approves the Contract amount attached hereto and made a part hereof as Exhibit A ("Contract") and authorizes the Mayor, or Mayor Pro Tempore in the Mayor's absence, to execute and deliver the Contract to proceed.

Section 3. <u>General Authority</u>. From and after the approval of this Resolution, the Mayor, Mayor Pro Tempore, City Manager, officers, and employees of the City of Thomasville, Georgia are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents as may be necessary to comply with the provisions of the Contract as executed and are further authorized to take any and all further actions and execute and deliver any and all other documents and certificates, including but not limited to the Contract, as may be necessary or desirable in connection with the execution and delivery of the Contract and any related documents, all of the forgoing in consultation with the City Attorney.

Section 4. Actions Approved and Confirmed. All acts and doings of the City Council, Mayor, Mayor Pro Tempore, the City Manager, the officers, and employees of the City of

Thomasville, Georgia that are in conformity with the purposes and intents of this Resolution and in the furtherance of the Change Order and the execution, delivery, and performance of the Change Order and related documents shall be, and the same hereby are, in all respects approved and confirmed.

Section 5. <u>Severability of Invalid Provisions</u>. If any one or more of the provisions herein contained shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such provisions shall be null and void and shall be deemed separable from the remaining provisions and shall in no way affect the validity of any of the other provisions hereof or of the Change Order ratified hereunder.

Section 6. <u>Repealing Clause</u>. All resolutions or parts thereof in conflict with the provisions herein contained are, to the extent of such conflict, hereby superseded and repealed.

Section 7. Effective Date. This resolution shall be effective immediately upon its adoption.

REPORTS

Mayor Pro Tem Scott introduced South Georgia Institute of Northwest University's Coach Brown and other representatives of the athletics program. Coach Brown noted that SGI ran two baseball seasons; Fall and Spring, as well as basketball. Following introduction of those present Coach Brown noted it was their hope that SGI could get permission for exclusive use of Northside Park in Thomasville as their Home Baseball Field. Coach Brown indicated they while they did not have dedicated funding, they were willing to provide any sweat equity needed to help get the park up to a Home Field standard with the City's assistance. He further indicated this could provide an economic impact for Thomasville, as home events would bring the coaches, players and their families and friends to Thomasville for overnight stays. City Manager White inquired if the group had spoken with the City's Director of Parks and Recreation, Mike Owens about this endeavor. Coach Brown indicated that that had spoken with Mr. Owes; but also wanted to speak directly to Councilmembers to gain their support as well. Councilmembers thanked the Coaches and for attending the meeting and provided best wishes for their endeavor.
