**General Easement**

**WITNESSETH:**

That in consideration of the sum of One (\$1.00) Dollar and other good and valuable considerations, receipt of which is hereby acknowledged, Party of the First Part has granted, bargained, sold, and conveyed, and does hereby grant, bargain, sell and convey unto Party of the Second Part a perpetual BLANKET easement, together with all rights and privileges hereunto appertaining, to construct, operate and maintain lines, conduits, pipes, wires, poles, fixtures, attachments and equipment for the transmission and distribution of **ELECTRICITY and TELECOMMUNICATIONS**, together with the right of ingress and egress to, from and along such lines, pipes, and conduits. Also the right to trim, or to remove any trees, undergrowth and other obstructions along and adjacent to said lines to the extent reasonably necessary to keep the wires, pipes and conduits clear, and to maintain and operate such lines, pipes and conduits with safety; also to erect and set necessary guy and brace poles and anchors and also the right to lay said pipes and conduits beneath the ground to the required depth. And to do all things necessary to completely and reasonably construct and maintain the foregoing.
